
ON HEARING the submission of counsel for the Applicant and other self-represented individuals,

THIS COURT ORDERS THAT:

1. The above-noted style of cause shall be the amended style of cause of this matter moving forward. For ease of reference, the following abbreviated style of cause may be used for the filing of court documents:

2. This Order shall be served on the assessed owners and those awarded allowances by regular mail. It shall also be published in the newspaper of daily record and posted on the Applicant's website.
3. Memoranda of Appearances shall be filed with the municipality by both parties and participants no later than September 26, 2014 on the form attached to this Order as Schedule 1.
4. Parties and participants shall file a Statement of Issues with the municipality, which shall not exceed one page in length, no later than October 10, 2014.
5. Participants will be allowed to make oral or written submissions only without a right of cross-examination or other rights which a party would customarily have.
6. The matter is adjourned to November 4 and 5, 2014 for a hearing of the issues.
7. Materials for the substantive hearing shall be served on the parties in the normal course and posted to the municipality's website by October 24, 2014.
