

Fee Assistance In Recreation (F.A.I.R)

What is the Fee Assistance In Recreation Program?

The Sport & Recreation division recognizes the financial barriers which interfere with the ability to participate in recreational activities. The Fee Assistance in Recreation (F.A.I.R.) provides fee assistances for Innisfil residents who are in financial need. The *Recreation – F.A.I.R* program enhances access to Town of Innisfil municipal recreation programs.

Who is Eligible for the Program?

The Town of Innisfil will not turn down an applicant due to the inability to pay. Innisfil is committed to making all our recreation programs accessible for all. However, you must be a resident of Innisfil to be considered for the program.

Amount of Assistant

Applicants may receive up to 25% off program registration fees to a maximum of \$200 per year / per participant. The F.A.I.R assistance is only to be applied towards Town of Innisfil program registration fees.

How does the Fee Assistance Program Work?

There is an initial application that is required to be completed and submitted in confidence to the Sport & Recreation division. Once a resident has been approved for the program, the resident will identify the activity / programs that they would like to participate / register for. Staff will work with the residents to allocate the funds.

How to Apply:

Step 1: Complete the application form below.

- The form can be printed or fill out electronically
- You can contact the Sport & Recreation division to have a physical copy mailed to you
- You can pick up a physical copy at Innisfil Town Hall

Step 2: Provide proof of residency in Innisfil which may include:

- A photocopy of your driver's licence
- A photocopy of recent utility bill with your name and address
- A copy of a municipal property tax bill

Step 3: Provide one proof of financial eligibility, which may include:

- Letter from Social Agency or Religious Institution
- Letter from School Official
- Letter from Member of Council
- Letter from Supporting Agency (i.e. Respite Worker, Social Servicers, etc.)

Step 4: Complete a Town of Innisfil Recreation Program Registration Form.

Step 5: Return your application form and supporting documents to:

Town staff will contact you to inform you of your application status. The application may take approximately 10 days to process.

Application Readiness:

To make the approval process go faster, please ensure the following items are returned (see above for examples of each item):

- F.A.I.R Application Form
- Proof of residency document
- Letter of Support
- Town of Innisfil Recreation Program Registration Form

Deadlines for Applications:

Applications must be received a minimum of 2 weeks prior to the start of the activity or program.
