

COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-005-2025

TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Maryam Azimi**, **Applicant**, on behalf of **Sean Ryan**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject properties are described legally as PLAN 1366 LOT 3 known municipally as 2314 Somers Blvd and is zoned "Residential (R1)".

The applicant is seeking relief from Section 3.18.3(d) of the Zoning By-Law that describes lots with a lot frontage equal to or greater than 15m, to have a maximum interior width of a private garage up to 50% of the width of the main wall of the principal building, to a maximum of 9m when the garage doors open to face the front yard. The applicant is proposing an increased interior width of approximately 11m.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within <u>ONE YEAR</u> from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

Planning

- 1. That the variance only applies to the submitted revised drawings and that any future development of the lands be subject to the Zoning By-law.
- 2. That the existing mature trees and hedges along the property lines be protected and maintained to the extent possible to the satisfaction of the Town. A tree preservation/planting plan shall be prepared to the satisfaction of the Town, proposing tree compensation and replacement rates for any trees to be removed, location of new trees, and tree protection measures during construction of the dwelling and attached garage.
