

## COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-021-2025

**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Waylon and Jenny Pigott**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject properties are described legally as **PLAN 843 LOT 6** known municipally as **682 9<sup>th</sup> Line** and is zoned **"Residential (R1)"**.

The applicant is seeking relief from Section 4.2a of the Zoning By-Law which permits a maximum lot coverage of 35%. The applicant is proposing to construct an attached garage with a second storey accessory dwelling unit that will increase the lot coverage to approximately 39.4%.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

L The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.
