TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Nicole Sgrignuoli, Applicant** on behalf of **Innisfil Land Holdings LP, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject properties are described legally as **INNISFIL CON 6 S PT LOT 23 RP 51R40460 PT PART 2** known municipally as **1150 6th Line** and is zoned "**Residential Townhouse Exception 14 (RT-14)**".

The applicant is proposing to construct 3-storey townhouses and seeking relief from Section 4.2b of the Zoning By-Law which requires a minimum landscape open space of 35% and the applicant is proposing approximately 28%. The applicant is also seeking relief for building height as the maximum permitted is 11m and the applicant is proposing approximately 12.5m

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

Planning

1. That the variances only apply to the submitted drawings, subject to minor revisions, that provide a minimum 28% landscaped open space and a maximum height of 12.5 metres, and that any future development of the lands be subject to the Zoning By-law.
2. That the variances apply exclusively to the townhouse Block 113 and 114 shown on the draft M-Plan submitted with variances application A-030-2025 & A-031-2025.
