TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Baldassarra Architects Inc., Applicant** on behalf of **Watersand ICI Developments Inc. C/O Metrus Construction Limited, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject properties are described legally as **CON 9 PT LOT 8 RP 51R4315 PART 1** known municipally as **3260 9th Line** and is zoned "**Industrial Business Park Exception 8 (IBP-8)**".

The applicant is proposing to construct an industrial development on the proposed lands and seeking relief from Section 3.35.1.1 of the Zoning By-law to reduce the number of required parking spaces from 234 to 145 spaces.

The applicant is seeking relief from Section 3.34(c) of the Zoning By-law to permit outdoor storage in the minimum required rear yard setback where the By-law prohibits storage in this location.

The applicant is also seeking relief from Section 6.2 of the Zoning By-law to increase the building height from the maximum permitted of 11m to approximately 23.8m.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
