The applicant is seeking relief from Section 4.2a of the Zoning By-law for an as-built shed. The required minimum interior side yard setback for an accessory building is 1m. The proposed setback is approximately 0.51m

L9S 1A1 no later than 4:30 p.m. on November 5, 2025. The filing of an appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day. The appeal fee of \$1,100 can be paid online through e-file or by certified cheque/money order to the Minister of Finance, Province of Ontario.
