**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **MEHR HAZARI, applicant**, on behalf of **PARKBRIDGE LIFESTYLE COMMUNITIES INC., owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The properties in the subject subdivision described legally as **51M-1189**, known municipally as **Innis Village** and zoned as **"Residential 1 Exception 12 Zone, Residential 2 Exception 7 and Residential 3 Exception 3 (R1-12, R2-7 and R3-3)"**.

**The applicant is proposing to construct multiple residences with a garage width of 60% of the main wall width of the dwelling. The applicant is seeking relief from Section 3.18.3 d) of the Zoning By-law which states that on lots with a frontage equal or greater than 15 m, the maximum interior width of a garage shall be 50% of the width of the main wall of the principal building.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
