

COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-052-2022

TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Francesco Fiorani**, applicant, on behalf of **Victoria Muzychka**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as CON 4 PLAN 96 S PT LOT 676 S PT LOT 677 is known municipally as 1015 Arnold Street, and is zoned as "Residential 1 Zone Exception 14 (R1-14)".

The applicant is proposing to create a third Accessory Dwelling Unit (ADU) on the property. The applicant is seeking relief from Section 3.5 a) of the Zoning By-law which permits a maximum of two accessory dwelling units per residential lot.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

L The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.
