

### COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-062-2022

**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Greg Lang**, **Applicant**, on behalf of **Shannon Lang**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as CON 5 S PT LOT 1, is known municipally as 4178 5<sup>th</sup> Line, and is zoned as "Agricultural (AG)".

The applicant is proposing to construct a detached accessory dwelling unit located 146 metres from the principal dwelling. The applicant is seeking relief from 3.5 (i) of the Zoning By-law which states any detached accessory dwelling shall not be located more than 60 metres from the principal dwelling on the lot.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.
