APPLICATION NO. A-72-2022**

**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Lorelie Spencer, Applicant**, on behalf of **2844365 Ontario Inc**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 1249 PT LOT 1**, is known municipally as **1018 Innisfil Beach Road**, and is zoned as **“Mixed Use 2 (MU2)”**.

**The applicant is proposing to construct a mixed-use building with a total of 4 accessible parking spaces. The applicant is seeking relief from Section 3.35.3 of the Zoning By-law which would require 8 accessible parking spaces.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. - The Committee **DEFERRED** the application.

In accordance with Section 17 (36) of the Planning Act, you may appeal to the Local Planning Appeal Tribunal (LPAT) against the decision by filing with the Secretary Treasurer of the Committee of Adjustment a notice of appeal setting out written reasons in support of the appeal and accompanied by a certified cheque or money order made payable to the Minister of Finance, in the amount of \$400 being the current fee prescribed by the Tribunal under the Local Planning Appeal Tribunal Act. The LPAT prescribed Appellant Form (A1) must be filed with any appeal to the Local Planning Appeal Tribunal.
