**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Cornelia Vanderzwaag, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **CON 10 PLAN 764 PT LOT 60 RP 51R12722 PART 2**, is known municipally as **2710 Ireton Street**, and is zoned as **“Residential 1 Zone (R1)”**.

**The applicant is proposing to construct a new deck with a deficient side yard setback of 2.1 m. The applicant is seeking relief from Section 3.54 (f) (iii) of the Zoning By-law which requires a minimum exterior side yard setback of 3m.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. - The Committee **DEFERRED** the application.
