



## COMMITTEE OF ADJUSTMENT NOTICE OF PUBLIC HEARING APPLICATION NO. A-002-2023

**TAKE NOTICE** that an application has been received by the Town of Innisfil from **Michael and Cynthia Taylor, Owners,** for a minor variance from Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as PLAN M701 LOT 31, is known municipally as 1983 Romina Court, and is zoned as "Residential 2 Zone (R2)".

The applicant is proposing to legalize two existing sheds with a deficient rear yard setback of 0.69 m and a deficient interior side yard setback of 0.66 m. The applicant is seeking relief from Section 4.2(b) of the Zoning By-law which requires a minimum rear yard and interior side yard setback of 1 m for accessory structures.

The Committee of Adjustment for the Town of Innisfil will consider this application through a conference call on **Thursday**, **January 19**, **2023**, **at 6:30 PM**.
