TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from Brad Dumond, Applicant, on behalf of Brandon Cook, Owner, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the Planning Act, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as PLAN 1036 LOT 52, is known municipally as 731 Pinegrove Ave, and is zoned as Residential 1 Zone (R1) and Environmental Protection (EP).

The applicant is proposing to construct a detached garage with a gross floor area of 76 m2. The applicant is seeking relief from Section 3.3(b) of the Zoning By-law which permits a maximum gross floor area of 50 m2.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

**NOTICE OF LAST DATE OF APPEAL**

In accordance with Section 17 (36) of the Planning Act, you may appeal to the Local Planning Appeal Tribunal (LPAT) against the decision by filing with the Secretary Treasurer of the Committee of Adjustment a notice of appeal setting out written reasons in support of the appeal and accompanied by a certified cheque or money order made payable to the Minister of Finance, in the amount of \$400 being the current fee prescribed by the Tribunal under the Local Planning Appeal Tribunal Act. The LPAT prescribed Appellant Form (A1) must be filed with any appeal to the Local Planning Appeal Tribunal. A detailed tree protection and planting plan shall be prepared to the satisfaction of the LSRCA and the Town, proposing tree compensation and replacement rates for any trees to be removed, and location of new trees and tree protection measures during construction.
