TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **David Mortley, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 1331 PT LOT 52**, is known municipally as **8 Church Street**, and is zoned as **“Residential 1 (R1)”**.

The applicant is proposing to construct a detached garage with a gross floor area of 53.42 m². The applicant is seeking relief from Section 3.3 (b) of the Zoning By-law which permits a maximum gross floor area of 50 m² for all accessory structures in residential zones.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. - The Committee **DEFERRED** the application.

CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within **ONE YEAR** from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

Planning Services

1. That applicant/owner shall confirm that an entrance permit from the Town of Innisfil has been obtained for the driveway/access to Elizabeth Street
2. That the proposed garage be constructed substantially in conformity with the drawings submitted with A-019 and A-020-2023.
3. That confirmation be provided that no trees are being removed and that tree protection fencing be provided where applicable on the site plan drawings in accordance with Town standards. If any trees are proposed to be removed during construction, a tree preservation/planting plan shall be prepared to the satisfaction of the Town, proposing tree compensation and replacement rates for any trees to be removed, location of new trees, and tree protection measures during construction of the accessory dwelling unit.

Engineering

4. The Applicant/Owner shall prepare and submit engineering design drawings and all other supporting documents in accordance with Town Standards and to the satisfaction of the Town.
