TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Hojjat Pysiehbazi, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 1449 LOT 11** is known municipally as **2192 Richard Street**, and is zoned as **“Residential 1 (R1)”**.

The applicant is proposing to construct a detached accessory dwelling unit (ADU) with a gross floor area of 68.49 m². The applicant is seeking relief from Section 3.5 (b) of the Zoning By-law which permits a maximum gross floor area coverage of 50% of the gross floor area of the principal dwelling on the lot.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **DEFERRED** the application.

CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within **ONE YEAR** from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

Planning Services

1. That any existing trees along the property lines be protected and maintained to the extent possible to the satisfaction of the Town. If any trees are proposed to be removed during construction, a tree preservation/planting plan shall be prepared to the satisfaction of the Town, proposing tree compensation and replacement rates for any trees to be removed, location of new trees, and tree protection measures during construction of the accessory dwelling unit.
2. That the proposed ADU be constructed substantially in conformity with the drawings submitted with A-021-2023 and A-022-2023.

Engineering

3. The Applicant/Owner shall prepare and submit engineering design drawings and all other supporting documents in accordance with Town Standards and to the satisfaction of the Town.
