TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Salvatore Chiovetti, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 51M1057 LOT 2**, is known municipally as **63 Victoria Street East**, and is zoned as **"Residential 1 Exception 21 (R1-21)"**.

The applicant is proposing to construct a deck which will result in a lot coverage of 49%. The applicant is seeking relief from Section 4.3.3.20 (b) (iii) of the Zoning By-law which permits a maximum lot coverage of 40%.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
