TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **David Iacono, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 767 LOT 91**, is known municipally as **1076 Spruce Road**, and is zoned as **"Environmental Protection (EP)"** and **"Residential 1 (R1)"**.

The applicant is proposing to construct a new dwelling with an associated second driveway. The applicant is seeking relief from Section 3.18.1(g) of the Zoning By-law which permits a maximum of one driveway per residential lot.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within **ONE YEAR** from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

Planning Services

1. That the variances only apply to the submitted drawings and that any future development of the lands be subject to Planning Act regulations.
2. That the applicant provide a detailed planting plan for the vegetation protection zone of Belle Aire Creek, to provide a buffer to the existing watercourse to the satisfaction of the Town and LSRCA.
3. That existing trees be protected and maintained to the satisfaction of the Town. A tree preservation/planting plan shall be prepared to the satisfaction of the Town, proposing tree compensation and replacement rates for any trees to be removed, and location of new trees and tree protection measures during construction of the proposed development.

Engineering Services

1. The Applicant/Owner shall prepare and submit engineering design drawings and all other supporting documents in accordance with Town Standards and to the satisfaction of the Town.
2. The Applicant/Owner shall undertake and submit a tree inventory, tree preservation, and tree compensation plan to the satisfaction of the Town.

Lake Simcoe Region Conservation Authority

1. That the Applicant/Owner provide the required fee payment for Minor Variance (Minor – Planner Review Only) of \$536.00, as per the LSRCA Fee Schedule.
2. That a planting plan be prepared for the buffer to the watercourse to the satisfaction of the LSRCA.
3. That the applicant/owner successfully obtain a permit from the LSRCA.
