#### CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within **ONE YEAR** from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

### **Planning Services**

- 1. That the variances only apply to the submitted drawings and that any future development of the lands be subject to the Zoning By-law.
- 2. That the applicant provides a Tree Planting/Restoration Plan to the satisfaction of the Town and the LSRCA.
- 3. That any existing trees and boundary trees be protected and maintained to the satisfaction of the Town. A detailed tree protection and planting plan shall be prepared to the satisfaction of the LSRCA and Town, proposing tree compensation and replacement rates for any trees to be removed, and location of new trees and tree protection measures during construction.
- 4. That the proposed garage be utilized for non-commercial purposes only, in accordance with the provisions of the R1 Zone

### **Engineering Services**

- 1. That the Applicant/Owner shall prepare and submit engineering design drawings and all other supporting documents in accordance with Town Standards and to the satisfaction of the Town.
- 2. That the Applicant/Owner shall undertake and submit a tree inventory, tree preservation, and tree compensation plan to the satisfaction of the Town.

### **Lake Simcoe Region Conservation Authority**

- 1. That the Applicant/Owner provide the required fee payment for Minor Variance (Minor Planner Review Only) of \$536.00, as per the LSRCA Fee Schedule.
- 2. That a planting/restoration plan be prepared for the buffer to the key natural heritage features to the satisfaction of the LSRCA.
