

#### COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-039-2023

TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from Yu Chu Su, Applicant, on behalf of Mike Burnell, Owner, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the Planning Act, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as PLAN M16 LOT 32, is known municipally as 3278 Oak Street and is zoned as "Residential 1 (R1).

The applicant is proposing to construct a garage projecting 11.6 m from the main front wall of the dwelling. The applicant is seeking relief from Section 3.18.1 (e) of the Zoning By-law which permits a maximum projection of 1 m on lots with a frontage of less than 20 m.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. The Committee DEFERRED the application.

# **CONDITIONS OF APPROVAL**

The below Condition(s) of Approval shall be completed within <u>ONE YEAR</u> from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

### **Planning Department**

- 1. That the applicant provides a revised front elevation drawing to the satisfaction of the Town to add architectural features to further blend the garage in with the dwelling.
- 2. That the variance only applies to the submitted revised drawings noted in Condition #1 and that any future development of the lands be subject to the Zoning By-law.
- 3. That the existing mature trees and hedges along the property lines be protected and maintained to the extent possible to the satisfaction of the Town. A tree preservation/planting plan shall be prepared to the satisfaction of the Town, proposing tree compensation and replacement rates for any trees to be removed, location of new trees, and tree protection measures during construction of the dwelling and attached garage.
