**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Peter McGill, Applicant**, on behalf of **Patrice Tinti, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 593 LOTS 150 & 151**, known municipally as **3967 Algonquin Avenue**, and is zoned "**Residential 1 (R1)**".

**The applicant is proposing to sever a portion of the lot for the purpose of creating a new residential lot. The severed lands will have a deficient proposed lot area of 699.8 m<sup>2</sup>. The applicant is seeking relief from Section 4.2 a) of the Zoning By-law which requires a minimum lot area of 1,400 m<sup>2</sup> for un-serviced R1 zoned properties.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
