

## COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-044-2023

**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Daniele Orsini**, **Applicant**, on behalf of **Anita Martello**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 596 PT BLK A**, is known municipally as **3944 Lakeview Road**, and is zoned as **"Residential 1 (R1)"**.

The applicant is proposing to construct a garage addition with a deficient rear yard setback of 0.69 metres. The applicant is seeking relief from Section 4.2(a) of the Zoning By-law which requires a minimum rear yard setback of 6 metres.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

L The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.
