**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Daniele Orsini, Applicant**, on behalf of **Anita Martello, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 596 PT BLK A**, is known municipally as **3944 Lakeview Road**, and is zoned as **"Residential 1 (R1)"**.

**The applicant is proposing to construct a garage addition with a deficient rear yard setback of 0.69 metres. The applicant is seeking relief from Section 4.2(a) of the Zoning By-law which requires a minimum rear yard setback of 6 metres.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
