TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Michael Habashi, Applicant**, on behalf of **Mina Shenouda, Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 51M1105 PT BLK 37 RP 51R41225 PARTS 18 AND 19**, is known municipally as **2021 Mullen Street**, and is zoned as **"Residential Townhouse Exception 16 (RT-16)"**.

The applicant is proposing to construct a second storey deck which will result in a lot coverage of 58%. The applicant is seeking relief from Section 4.3.8.16 (a) of the Zoning By-law which permits a maximum lot coverage of 55%.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.
