COMMITTEE OF ADJUSTMENT NOTICE OF DECISION APPLICATION NO. A-074-2023

TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Jason Mendosa**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 881 LOT 79** is known municipally as **876 Kennedy Road**, and is zoned as "**Residential 1 (R1)**".

The applicant is proposing to convert an existing accessory structure into an accessory dwelling unit with a footprint of 67.6 m^2 . The applicant is seeking relief from Section 3.5 (j) of the Zoning Bylaw which probits accessory dwellings with a footprint over 50 m^2 in the backyard.

The Committee of Adjustment has considered all written and oral submissions received before and/or

during the hearing as part of their decision. The Committee APPROVED the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained. See attached Condition(s) of Approval No Conditions The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. The Committee is further not satisfied that the application is desirable for the appropriate use of the subject property, or that it is minor in nature. The Committee **DEFERRED** the application.
