TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from Leanna Mohammed, Applicant, on behalf of Agostino Dimarsico, Owner, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 767 LOT 55** and is known municipally as **1041 Fern Avenue** and is zoned as "**Residential 1 (R1)**".

The applicant is proposing to construct a detached garage with a proposed Gross Floor Area (GFA) of 117.05 m². The applicant is seeking relief from Section 3.3(b) of the Zoning By-law permits a maximum gross floor area of 50 m² for accessory structures in residential zones.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.
