TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Dafne Gokcen**, **Applicant**, on behalf of **Tollendale Village**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as CON 13 PT LOT 18, known municipally as 1870 Big Bay Point Road, and is zoned "AG - Agricultural".

The applicant is proposing to construct a senior citizens residence development with deficient parking rate of 1.25 spaces per unit. The applicant is seeking relief from Section 3.35.1.1 (e) of the Zoning By-law which requires a minimum parking rate of 1.75 spaces per unit.

The appeal fee of \$400, the current fee prescribed by the Tribunal under the Local Planning Appeal Tribunal Act, can be paid online through e-file or by certified cheque or money order made payable to the Minister of Finance, Province of Ontario.
