**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application from **Lyndsey Tkaczuk, agent**, on behalf of **Lindsay and Colin Hutterer, Owners**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **PLAN 32 PT LOT 6 RP 51R17303 PART 1**, known municipally as **1 George Street (Unit B)** and is zoned **“Residential 3 Exception 1 (R3-1)”**.

**The applicant is proposing to construct a two-storey addition. The applicant is seeking relief from Section 3.27(a) of the Zoning By-law for the expansion of a legally existing, non-conforming use.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **DEFERRED** the application.
