TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **Dylan Moore, Agent**, on behalf of **North Town Developments Ltd., Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as **CON 15 PT LOTS 21 & 22 RP 51R25011 PT PART 1**, known municipally as **1291 Shore Acres Drive** and is zoned “**Environmental Protection (EP)**”, “**Open Space EXCEPTION 20 (OS-20)**”, “**Open Space (OS)**” and “**Residential 1 Exception 51 Holding Symbol (R1-51 (H))**”.

The applicant is proposing to construct four (4) model homes. The applicant is seeking relief from Section 3.30(b) of the Zoning By-law which permits a maximum of three (3) model homes on the subject lands.

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.

- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. The Committee is further not satisfied that the application is desirable for the appropriate use of the subject property, or that it is minor in nature.
- The Committee **DEFERRED** the application.

CONDITIONS OF APPROVAL

The below Condition(s) of Approval shall be completed within **ONE YEAR** from the Circulation Date of Notice of Decision outlined on Page 1. If the Condition(s) of Approval are not completed by this date, the application shall be deemed to have been refused.

Planning

1. That the variance only applies to the submitted drawings and that any future development of the lands be subject to the Zoning By-law.
2. That the demonstration units be contained with no access to the rest of the site, with dedicated access separate from construction access.
3. That the demonstration units shall comply with all applicable terms and conditions of the required demonstration unit agreement.

Lake Simcoe Region Conservation Authority (LSRCA)

1. That the Applicant/Owner shall pay the LSRCA Plan Review Fee in accordance with the approved LSRCA Fee Schedule. The applicable fee for Minor Variance (Minor – planner review only) is \$536.
