The applicant is proposing to construct an Accessory Dwelling Unit (ADU) with an approximate footprint of 84.7 m². The applicant is seeking relief from Section 3.5(j) of the Zoning By-law which permits a maximum ADU footprint of 50m² if located the rear yard.
