P.13, as amended.

The subject property is described legally as CON 3 PLAN 616 LOT 10 and is known municipally as 1123 Stoney Point Road and is zoned as "Residential 1 (R1)".

The applicant is proposing to construct a dwelling with an approximate lot coverage of 45%. The applicant is seeking relief from Table 4.2(a) of the Zoning By-law which permits a maximum lot coverage of 35%.
