TAKE NOTICE that a decision has been made by the Committee of Adjustment, for a minor variance application from **James Hunter**, **Applicant**, on behalf of **1820839 Ontario Inc.**, **Owner**, for relief from the provisions of Zoning By-law 080-13, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

The subject property is described legally as PLAN 51M1045 BLK 39 and is known municipally as 299 Sunnybrae Avenue and is zoned as "Residential 1 Exception 52 Holding Symbol (R1-52(H))".

The applicant is proposing to construct a home with a deficient exterior yard setback of 4m. The applicant is seeking relief from Table 4.2(a) of the Zoning By-law which requires a minimum exterior side yard setback of 6m.
