NOW THEREFORE BE IT RESOLVED THAT Council defer the Engineer's Report entitled, "Final Drainage Report for the South Innisfil Creek Drain and Branches" dated August 15, 2013;

THAT Council directs staff to commence an application to the Drainage Referee for reconsideration, directions and clarification at the first available opportunity;

THAT Council directs staff to seek assistance from the Minister of Agriculture and Food/Premier and the provincial and federal governments with respect to the crippling costs associated with the proposed improvements to the South Innisfil Drain;

THAT Council directs staff to investigate potential funding sources that could assist with the proposed drainage works; and,

THAT Council request staff to meet with interested landowners within the South Innisfil Drain to receive recommendations regarding phasing and maintenance / repair options that could be considered by the engineer and that the engineer consider incorporating any changes to the report.
