

SHORT RULES

MAYOR'S GOLF TOURNAMENT PRIZE TABLE DRAW (The "Contest")

NO PURCHASE NECESSARY. No purchase method of entry is available, see complete Contest Rules.

The Contest is open to the attendees of the Mayor's Golf Tournament held at The Nest Golf Club located at 3800 Friday Dr, Innisfil, ON, L9S 3E1 on June 16, 2025 (rain date June 23, 2025) or any resident of the Town of Innisfil, Ontario who wishes to participate and who has reached the minimum age of 18 year of age. The contest begins on June 16, 2025 (rain date June 23, 2025) at 8:00 am Eastern Standard Time ("EST") and ends on June 16, 2025 (rain date June 23, 2025) at 11:00 am EST (the "Contest Period"). To enter the contest, donate \$20.00 to Innisfil Community Foundation, and receive three (3) entry ballots per each donation. **NO LIMIT OF ENTRIES PER PERSON DURING THE CONTEST PERIOD.** There are 10 Prizes available to be won with retail values of approximately \$100.00 – \$1000.00 each (see full Contest Rules for prize details). Place your ballots in the ballot boxes for the corresponding prize. You may enter as many ballots as you wish into any ballot box - entries are unlimited per person per prize. By making a donation and entering the Contest, you accept to be bound by the full Contest Rules. Winners have to answer a skill testing question to be awarded their prize. Winners may be required to sign and return a declaration and release. Odds of winning are based on the number of entries received per ballot box.

THIS CONTEST IS ONLY OPEN TO ATTENDEES OF THE MAYOR'S GOLF TOURNAMENT AND RESIDENTS OF INNISFIL AND IS GOVERNED BY CANADIAN LAW AND THE LAWS OF THE PROVINCE OF ONTARIO.

NO PURCHASE/DONATION NECESSARY. SEE BELOW FOR FULL CONTEST DETAILS. PARTICIPATION IN THIS CONTEST CONSTITUTES YOUR FULL AND UNCONDITIONAL ACCEPTANCE OF, AND AGREEMENT TO BE LEGALLY BOUND BY, THESE CONTEST RULES (THE "**CONTEST RULES**").

CONTEST PERIOD

The Contest begins on June 16, 2025 (rain date June 23, 2025) at 8:00 am Eastern Standard Time ("EST") and ends on June 16, 2025 (rain date June 23, 2025) at 11:00 am EST (the "**Contest Period**").

ELIGIBILITY

The Contest is open to all attendees of the Mayor's Golf Tournament (the "Tournament") and residents of Innisfil who are at a minimum 18 years of age, except Innisfil Community Foundation committee members (and those with whom such committee members are domiciled), its affiliated companies or agents, advertising and promotion agencies, and the Contest judges.

HOW TO ENTER

You will receive three (3) ballot per CAD\$20.00 donation to Innisfil Community Foundation. You will be required to write your name and phone number on each ballot you get. Select the prizes towards which you want to enter your ballots and place your ballots in the ballot box(es) of the corresponding prize(s) you choose (there are ten (10) prizes to choose from, see list of prizes for prize details). You may place as many ballots as you wish in each ballot box. Ballots per person are unlimited per prize. **NO LIMIT OF ENTRIES PER PERSON DURING THE CONTEST PERIOD.**

All entries must be received prior to 8:00 am EST on June 16, 2025 (rain date June 23, 2025). Any entries received after this time, regardless of whether or not proof of transmission prior to the Contest closing can be substantiated, will not be considered to have been received during the Contest Period and will not be included in the Contest.

Each ballot will have a chance of winning one (1) prize out of the pool of prizes.

NO PURCHASE NECESSARY. To receive one (1) entry without making a purchase, you will be required to address the Mayor's Golf Tournament attendees (or designate) with a 2-minute speech on the topic of "The impacts of the Innisfil Community Foundation has had on the community and why it is important to continue to support the Foundation". To submit your entry without making a purchase, speak to the Sponsor representative responsible for accepting donations at the Tournament.

JUDGING CRITERIA FOR SELECTING FINALISTS

Ballots will be drawn at approximately 11:00 am ET on June 16, 2025 (rain date June 23, 2025) at The Nest Golf Club located at 3800 Friday Dr, Innisfil, ON, L9S 3E1. A total of 10 draws (one for each available prize) will be held. One (1) ballot will be drawn from the ballot box for each prize available. Each participant whose ballot is selected from the draw will be notified that they were selected via text message sent to the phone number they provided when entering in the Tournament. Before being declared a winner, the selected participant must correctly answer a time limited mathematical skill-testing question administered in writing.

The winner will receive their prize from the Sponsor prior to the winner leaving the Tournament. If the selected winner does not claim their prize prior to their departure from the Tournament, then they will be disqualified and forfeit their prize. The prize will be considered unclaimed, and no other entry will be drawn. Prizes must be accepted as awarded and are not transferable or convertible to cash. No substitutions except at Sponsor's sole option. Prizes will only be awarded to the person who was the owner of the winning ballot.
